## WASTE MANAGEMENT

All rubbish bins are located in the market grounds area, they are for the use of general public and stallholders. Stallholder's, large waste is to be placed in the large red waste bins provided within the grounds or at the main office.

Please ensure you sort your waste properly ie general waste, recyclable, cardboard ect. Used cooking oil is to be taken offsite and disposed of by stallholders.

## PARKING FOR STALLHOLDERS

Parking is available for stallholders as follows:

Car park opens at 6am

Stallholders are to have all vehicles removed from the inner village **before 7am** opening of markets, vehicles can be brought in **after 1pm** closing of markets.

Speed limit is 5kph

Hazard lights are to put on when driving vehicle within the village to set up

Designated carpark for stallholders is either beside office, amphitheatre or main entrance car park.

No parking is allowed in the front of the bottom amenities; this area is to be clear at all times for safety.

## FOOD VENDORS

All food vendors must have Qld State approval, display a current certificate of licence and registration, have completed a food safety supervisors course and any Government required COVID-19 checklist and certificates. Please refer to waste management for disposal of waste.

## POWER CORDS & ELECTRICAL ITEMS

All power cords and electrical equipment must be tagged and tested. If your items do not have a current tag you will be unable to use them. All power boards must have a safety switch. Bi annual test and tag audits are undertaken by OPT.

## TERMS AND CONDITIONS

By entering this market you are entering into a contract with YMCA Brisbane, on the following terms and conditions.

You must comply with all rules and directions displayed within the market and any directions given to you by authorised personnel. You must not cause obstruction, nuisance or disturbance. We reserve the right to remove any person(s) who does not comply with these terms and conditions.

You agree to indemnify us and our Management, employees, contractors and invitees in respect of any claim made against us and any loss, damage, charges or expenses incurred by us (including but not limited to, legal costs), which arise in any way from or in connection with your attendance at the market or the presence of any person or animal under your care or supervision at the Market, including without limitation any damage to any part of the Market or any property, equipment or other facilities in the Market or any death or injury of any person. This indemnity does not cease after you have left the Market and we may enforce this indemnity before incurring expenses.

We are not liable to you for, and you release us from, any loss or damage that you may suffer, or any loss or damage to any property or person whilst in the Market, unless the loss or damage is caused by, and only to the extent of, our wilful misconduct, negligence, or breach of statutory duty or warranty.

We are not liable to you for the safety of, or any damage to, your vehicle (or other mode of transport), and are not liable to you for any loss, damage, fees, expenses or fines which you may incur as a result or arising out of your attendance at the Market.

All animals must be kept on a leash and appropriately restrained at all times. You are responsible to pick up after your animal and dispose of all waste appropriately.

Stallholders must comply with OPT Emergency Evacuation Plan, by proceeding to designated assembly areas when directed.

Stallholders operate their business and site at their own risk. OPT accepts no responsibility for damages or cost associated with the actions of stallholders.

Storage of stallholder owned equipment is at owner's risk. OPT takes no responsibility for any damage, loss or theft.

OPT regularly reproduces, publishes and distributes photographs, recordings and images in a range of media include on social media, websites, promotional and marketing material in order to promote OPT. As a stallholder, you consent to OPT to use your name, likeness, digital images, films, video imagery, photographs, voice and sound recordings in any media, without remuneration.
